## "Last Queen Standing Promotion" OFFICIAL RULES

NO PURCHASE OR WIRE TRANSFER NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. THIS PROMOTION IS INTENDED FOR ENTRY IN THE UNITED STATES AND WILL BE GOVERNED BY U.S. LAW.

PARTICIPATING LOCATIONS: There will be multiple locations participating in this Promotion (each, a "Participating Location"). Participating Locations are located throughout the fifty (50) United States and the District of Columbia (excluding New York, Florida and Rhode Island). A complete list of the Participating Locations will be updated at www.lastqueenstanding.com (the "Website").

DATES: The "Last Queen Standing Promotion (the "Promotion") begins on May 16, 2024 ends when the fourth ( $4^{\text {th }}$ ) queen is revealed on the game board (the "Promotion Period"). The Promotion Period may end in as little as four (4) weeks or as long as fifty-four (54) weeks depending on when the queens are revealed. See the WINNING/NOTIFICATION section for complete details. For purposes of these Official Rules, all times are given in Central Standard Time ("CST"). The Sponsor's App (defined below) will be the official computer and time keeping device of this Promotion.

ENTRY PERIODS/DRAWINGS: The Promotion Period is subject to multiple giveaways (each, a "Giveaway"). There will be one (1) Giveaway held per calendar week, each Thursday of the Promotion Period (until all four (4) queens are revealed. Each Giveaway will have six (6) entry periods (each, an "Entry Period") and six (6) random drawings. Entrants must be present at the Participating Location for which they entered to win. The Giveaway Entry Periods and Drawings will commence each Tuesday as follows:

Prize distribution per Giveaway: There will be four (4) first prizes winners selected per Giveaway drawing (Entry Periods 1-5). For Entry Period 6, there will be one (1) grand prize winner (each, a "Grand Prize Winner")
selected. The First Prize Winners will each receive a "First Prize", and the Grand Prize Winners will receive a "Grand Prize". The Grand Prize Winner selected in each Giveaway (each Giveaway's sixth ( $6^{\text {th }}$ ) drawing) will also be eligible to participate in the "Last Queen Standing" event (the "Event") for a chance to win a jackpot prize ("Jackpot") for that Giveaway._There will be one (1) Event per Giveaway. ENTRY LIMITS: Entrants may only enter one (1) time per Giveaway. Non-winning eligible entries received in an Entry Period will be eligible and will carry over for subsequent drawings within the Giveaway.

Example: An entry received at 4:01 p.m. CT will be eligible for all six (6) drawings held for that Giveaway. Access the App via the Apple App Store or the Google Play Store and follow the instructions to download the App to your mobile device. Then, they must check into a participating location.

To enter, visit a Participating Location during a Giveaway's Entry Period and "check-in" to the Participating Location via the App. When prompted, choose one (1) card from the virtual game board. Each card is assigned a number, one (1) through fifty-four (54). Your card number will be stored within your App account and will only be valid for participation in the Event if you are selected as the Giveaway's Grand Prize Winner. Upon checking in to the App and selecting the card, Entrant will automatically earn one (1) entry into the drawing associated with the Entry Period for which he / she checked in. Such entry will also be eligible for each drawing held thereafter within the Giveaway.

WINNING/NOTIFICATION: There are two (2) ways to win prizes in a Giveaway (Entrants must be present at the Participating Location for which they entered to win):

To be eligible to participate in the Event, the Grand Prize Winner must visit his/her account within the App and press the "Confirm" button, indicating that he/she is present at the Participating Location for which he/she entered. If the Grand Prize Winner is not present at the Participating Location for which he/she entered, the Event will be cancelled for that Giveaway, and the Grand Prize Winner will no longer be eligible for a chance to win the Jackpot. In such case, the Grand Prize Winner will receive
his/her Grand Prize and the associated Jackpot will go unawarded for that Giveaway.
2. Last Queen Standing Event: There will be one (1) Event held for each Giveaway, at approximately 7:30 p.m. CT on the respective Giveaway date immediately following the $6^{\text {th }}$ drawing for the Grand Prize. At the Event, the Grand Prize Winner of that Giveaway will have the chance to participate for the chance to win a Jackpot. Prior to the start of the Promotion, the Sponsor will create a "Last Queen Standing" game board. The game board will be housed at the Sponsor's offices during the entire Promotion Period. The game board will include a deck of fifty-four (54) playing cards (a regular set of playing cards with two (2) jokers). The Sponsor will randomly shuffle the deck of cards, and randomly place each card upon the board face side down. Each card will be numbered, one (1) through fifty-four (54). Once the Sponsor has placed the deck of cards face side down on the game board and numbered them, the cards will not be moved or be changed during the Promotion Period EXCEPT during each live Event.

At each Event, the Sponsor will announce the Jackpot amount available to be won. After the Jackpot amount is announced, and at the signal of the Sponsor, the Grand Prize Winner will be asked to announce the card number he/she selected at point of entry (the card number the Grand Prize Winner selected at point of entry can be found within the Grand Prize Winner's account within the App). The Sponsor will verify the card number announced by the Grand Prize Winner against the Apps log records. Once this verification is complete, the Sponsor will turn over the corresponding card \# on the Game Board.

If the card revealed is a Queen, the Grand Prize Winner will win the Jackpot prize associated with the Queen he/she has overturned (see below). If a Queen is not revealed, the Grand Prize Winner has not won a Jackpot prize.

Jackpot Distribution: There are four (4) Queens in the deck of cards each associated with a Jackpot prize; therefore, there are four (4) opportunities to win a Jackpot prize throughout the Promotion Period. Jackpots are allocated as follows:

First Queen: Prize Winner will win \$1000.00.
Second Queen: Prize Winner will win $\$ 1500.00$.
Third Queen: Prize Winner will win $\$ 2000.00$.

No win: If no queen is revealed during the Giveaway 1 Event, the prize winner will would be awarded $\$ 250.00$, and the Jackpot will continue to grow. In this case, the Jackpot
available to be won for Giveaway 2 would be $\$ 16,000$.

The final winner who reveals the $4^{\text {th }}$ Queen will win the Jackpot.

#### Abstract

JACKPOT ODDS: Odds of winning the Jackpot for the first Giveaway are 4:54. Odds of winning the Jackpot thereafter will change as cards are flipped per Giveaway. Example: If a queen is revealed in the first Giveaway, odds of winning the Jackpot in the second Giveaway will be 3:53. If no queen is revealed in the first Giveaway, odds of winning the Jackpot in the second Giveaway will be $4: 53$... and, so forth.
